Best practices for quality of care

- Review children's immunization records before every visit and administer schedule vaccines.
- Educate and recommend immunizations to parents. Parents are more willing to agree with vaccinations when it is supported by the practice.
- Address any concern or common misconception about vaccinations.
- Have a prescheduled appointment for vaccines, along with reminders.
- Document the brand and manufacturer for the rotavirus vaccination.
- Members who are behind schedule for their immunizations should be caught up using the CDC's recommended catch-up schedule.

Quality score improvement tips

- In order to be compliant for this measure members must receive all of the immunizations listed above. Members who received some, but not all, of these immunizations do not contribute.
- Give immunizations within the scheduled timeframes. If vaccinations are given after the child's 2nd birthday, they will not count toward the measure.
- If the child comes from a different practice or state, please obtain the previous immunization records to continue care.
- Document parent refusals and place a signed copy in the medical record.
 - Note: this does not count towards compliance in HEDIS, but it does prevent additional outreach to the office attempting to capture the immunization.

Exclusions

- Members who used hospice services or elected to use a hospice benefit any time during the measurement year.
- Members who died any time during the measurement year.
- Members who had a contraindication to a childhood vaccine on or before their 2nd birthday:
 - Severe combined Immunodeficiency.
 - o Immunodeficiency.
 - o HIV.
 - o Lymphoreticular cancer, multiple myeloma or leukemia.
 - o Intussusception.
